






KC is a mandatory system to sell only the certified products by Radio Research Agency in accordance with item 2 of Article 58 of Radio Waves Act and is categorized into three systems of conformity certification, conformity registration and interim of conformity.




KOREA ENERGY EFFICIENCY & e-Standby

The Korean government has undertaken three energy efficiency management programs to increase the energy efficiency of appliances – energy standards and labelling, high-efficiency equipment certification and e-Standby.

- Energy standards and labeling system: Aims to improve energy efficiency in appliances regulates operational efficiency
- High-efficiency certification program: Dissemination of high-efficiency equipment for industry and buildings
- e-Standby: Regulation on standby power consumption
